

Circ 5 bbls water cmt to surf.

Cmtd 2nd stage w/300 sx Type III cmt w/8% Bentonite, 1/4 pps Celloflakes & 2% Phenoseal (11.9 ppg & 2.6 cuft/sx) f/b 100 sx Type III neat cmt (14.5 ppg & 1.39 cuft/sx). Good circ - no cmt back. TOC will be reported on next sundry. Completed cmt job on 5/1/07.
