05/14/07 spud 8-3/4" surface hole. Drilled to 145'KB. Ran 3 jts (136.45') of 7", 20#, J-55, ST&C new casing and set at 141'KB. Cemented with 65 sx (77 cu. ft.) of Type 5 with 3% CaCl₂ and 1/4 #/sk celloflake. Circulated 5 bbls of good cement to surface.

05/15/07 Nipped up the bradenhead and BOP. Pressure tested BOP to 250 psi low and 1000 psi. high.

05/18/06 TD 6-1/4" hole at 1934'. Ran 46 jts (1913.57') of 4-1/2", 10.5#, J-55, ST&C production casing and landed at 1913' KB. Insert float is at 1894'KB. Top of marker joint is at 1473'. Cemented with 150 sx (309cu.ft.) of Type 5, with 2% sodium metasilicate. 1/4#/sk celloflake, followed by 75 sx (89 cu. ft.) of Type 5, with 1/4# celloflake. Bumped plug to 1500 psi. Circulated 15 bbls of cement to the surface. Released rig @ 14:30 on 05/18/07.
