Cmtd 2nd stage w/530 sx Type III cmt w/8% Bentonite, 0.2% CD-32, 0.9% FL-52A & 2 pps Phenoseal (11.9 ppg & 2.61 cuft/sx) f/b 100 sx Type III neat cmt (14.5 ppg & 1.39 cuft/sx). Circ 100 hbbs cmt to surf. Completed cmt job on 5/22/07.
