**5/23-5/24/07 Drilled 12 1/4" hole to 185', ran 9 5/8", 36# J-55 STC Casing, landed @ 174' KB (KB=13.0) 5/24/07 Cemented with 141 sks, 15.2#, Type III Cement plus 3% CaCL, plus 0.25 lb/sk Celloflake, yield 1.28 (15.2 ppg) 180.48 cu. ft. We used 3 centralizers on the bottom 3 joints. Circulated 20 bbls cement to surface. Wait on cement 8 hours.**

**Tested BOPs 250# low for 5 minutes, and 2000# high for 5 minutes. Tested 9 5/8" casing to 600# for 30 minutes, held O.K.**

**Tagged cement @ 112' in 9 5/8" casing.**
