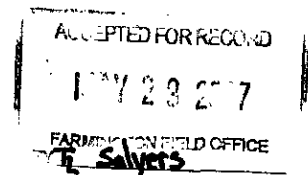

Plug down @ 1:30 pm on 05/18/07. Circulate 8 bbls cement to surface. WOC. RD Halliburton. RDMO. Surface casing test will be conducted prior to drilling out from under the surface. BIM will be notified to witness test.
