Ran total of 5 joints with 28 preperfed 0.75" holes in each. Top of the bottom preperfed joint is @ MD6577' w/bull plug on bottom. The other 4 preperfed joints are plugged and have tops @ MD5975', 5343', 4718', 4089'. Released drilling rig on 5/21/07. Waiting on completion rig.
