5/31-6/01/07 Drilled 12 1/4" hole to 225', ran 9 5/8", 36# J-55 STC Casing, landed @ 200' KB (KB=13.0) 6/01/07 Cemented with 196 sks, 15.2#, Type III Cement plus 3% CaCL, plus 0.25 lb/sk Celloflake, yield 1.28 (15.2 ppg) 250.88 cu. ft. We used 3 centralizers on the bottom 3 joints. Circulated 16 bbls cement to surface. Wait on cement 8 hours.

Tested BOPs 250# low for 5 minutes, and 2000# high for 5 minutes. Tested 9 5/8" casing to 600# for 30 minutes, did not hold. Casing bled from 600 psi to 250 psi in over 30 minutes time. Joe Ruybalid, BLM Representative was on location at time of testing, and gave the go ahead to continue drilling. He will present when we pressure test the 7" casing.

Tagged cement @ 135' in 9 5/8" casing.
