Cement with 125 sks Class G, 2% CaCl₂, 1/8#/sk floccle (148 cu.ft.). Plug down @ 1:30 pm on 06/01/07. Circulate 14 bbls cement to surface. WOC. RD Halliburton. RDMO. Surface casing test will be conducted prior to drilling out from under the surface. BLM will be notified to witness test.
