Cement with 125 sks 65/35 Class G poz, 2% CaCl2, 1/4#/sk floccle (148 cu.ft.). Plug down @ 5:45 pm on 05/24/07. Circulate 16 bbls cement to surface. WOC. RD Halliburton. Surface casing test will be conducted prior to drilling out from under the surface. BIM will be notified to witness test.
