Devon Energy Production Company, L.P. would like to give notification of tubing and packer set in the above well. On 5/16/07 276 jts of 2 3/8", 4.7#, J-55, tubing was set to a depth of 8,689'. A 4 1/2" Quad Cup packer was set at 6,757' with 10,000#.

✓ On 4-6-07 a 4 1/2" CIBP was run into the casing and set at 8,750'. 10' of Portland cement was dumped ontop of CIBP and tested to 3800 psi, tested ok.
