Remarks: A CBL was run on 03/07/07 and indicated TOC @ 3100' (7" shoe @ 2998'). On 3/9/07 COPC contacted Steve Mason (BLM) and Henry Villanueva (OCD) to inform TOC and discuss possible remediation. Remediation deemed not necessary at that time contingent upon COPC monitoring bradenhead and csg for pressures. This well completed 06/13/07 and had 170# bradenhead pressure.
