The APD intermediate casing depth was approved for 3807'. We are requesting to set the intermediate casing @ 3857' to ensure Adequate separation between the Lewis and the water in the Pictured Cliffs. We will be running 423' of 4 1/2" 11.6# J-55 LT & C Casing on the bottom of the production string, 4 1/4" 10.5# J-55 ST & C in the middle, & 4 1/2" 11.6# J-55 LT & C on the top 1350' Of the production string. Cement volumes will be adjusted accordingly.
