It is intended to remove the packer and commingle the subject well in the Basin Dakota (Pool Code 71599) and Blanco Mesaverde (Pool Code 72319). The production will be commingled according to Oil Conservation Division Order Number 11363. Since this well has production history to use for allocation, the percentage will be 88% Mesaverde and 12% Dakota for gas and 100% for MV condensate. Commingling will not reduce the value of production (our normal Allocation document will be submitted shortly). The Bureau of Land Management Office has been notified in writing of this application.

Interest owners in both zones are common the two zones, so no notification is necessary.
