McElvain Oil and Gas Properties, Inc. proposes to recompleate this well from the Gavilan Mancos to the Mesaverde. The Dakota will be permanently abandon by placing a CIBP at +/-8100' and capped with a 50' cement plug. The existing open perfs (7092'-7242') will be permanently isolated by placing a CIBP at +/- 7090' and capped with a 50' cement plug. A bond log will be run and the open interval across the Meneffe and Pt. Lookout will have cement circulated thru perfoations placed above the original cement top (estimated at 6276') and below the DV tool at 5762'. The remaining Mancos interval will be permanently abandoned by leaving a cement retainer used in conjunction with the squeeze procedure. The retainer will be capped with 50' of cement. Selected intervals (6063'-6095', 5937'-6037', 5658'-92', 5604'-5612') in the Mesaverde will be perforated and tested then fracture stimulated if required.
