On or about September 11, 2003 the well will be reperforated in the following intervals:

2924' to 2945' with four shots per foot;

2945' to 2957' with two shots per foot;

2957' to 2980' with four shots per foot.

The perforations will be acidized with 500 gallons of 15% HCL. New 1 1/2" tubing will be placed in the well to a bottom depth of 2952'.
