Completion rig was rigged up on August 21, 2003. Well entered and casing pressure tested at 1,000 psi for 30 minutes. Pressure held. First DV tool drilled out at 2,423'; casing tested at 1,000 psi 30 minutes; pressure held. Second DV tool drilled out at 5,347'; well cleaned out to 5,867'; casing tested to 3,000 psi for 30 minutes; pressure held.

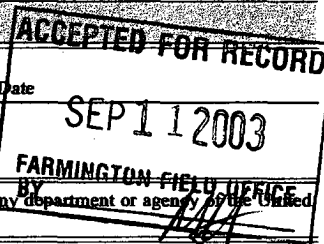
