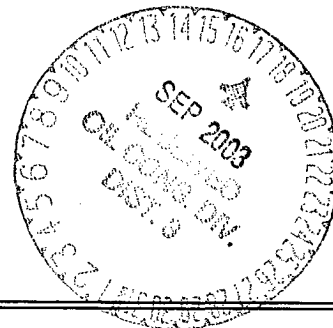

Circ. 15 bbls good cement to surface. WOC. NU WH & NU BOP. PT - OK. PT casing to 250 psi low and then 1000 psi for 30 minutes. Good test.
