In an attempt to return this well to production, we intend to refrac the Pictured Cliffs as follows:

1. MIRU. TOH w/tubing.
2. TIH w/bit and circulate hole clean. Pressure test casing to 500 psi.
3. RU wireline and perforate the Pictured Cliffs from 3067'-3132'.
4. TIH w/packer and 3 1/2" workstring to 3050'. Fracture treat PC with a 70Q foam.
5. Flow back well for cleanup. TOH laying down frac string.
6. TIH and clean out to PBTD.
7. Land tubing at bottom perforation and return to production.
