Casing leak was repaired as follows:

08/04/03 MIRU. TOH with rods. ND wellhead. TOH with 2-3/8" tubing.
08/05/03 TIH and set RBP @ 4220'. TOH. TIH with 4-1/2" packer, set @ 4030'. Test RBP-ok. TOH.
08/06/03 TIH with 7" packer. Isolate casing leak from 2030' to 2089'. PUH to 1904', set packer.
08/07/03 RU BJ Services. Squeeze leak with 150 sks Class C, 2% CaCl₂, 0.3% FL-52. Release packer.
TOH. WOC.
08/08/03 TIH with 6-1/4" bit. Tag cement @ 1954'. Drill out to 2094'. Test casing to 500 psi-ok.
TOH. TIH and retrieve RBP.
08/11/03 TIH with tubing and clean out to 4590' with air mist. TOH. Ran 145 jts. 2-3/8" tubing,
set @ 4505'. Ran rods and pump. Hung on pumping unit. Return to production.
