The Gavilan Mancos was permanently abandoned by setting a CIBP @ 7125'. The CIBP was tested to 500 psi and capped with 50' cement via a dumpbailer. Another CIBP was set @ 6356' and capped with 50' cement via a dumpbailer.

The Pt. Lookout was perforated 6116'-6126' w/ 2spf, acidized with 250 gal 15% HCl and frac'd w/ 31,360# 20/40 sand, 11, 310 gal 2% KCl and 444,040 scf nitrogen. A CIBP was set @ 6110'. The CIBP was tested to 500 psi and capped with 25' cement via a dumpbailer. The Menefee was selectively perforated 5848'-5988' with 20 holes, acidized with 1000 gal 15% HCl and frac'd with 58,840# 20/40 sand and 61,446 gal slickwater. The Cliffhouse was selectively perforated 5753'-5772' with 38 holes, acidized with 1000 gal 15% HCl and frac'd with 29,900# 20/40 sand and 36,750 gal slickwater.
