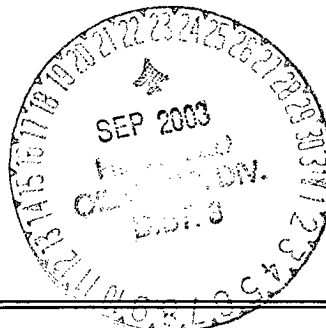

Pumped a preflush of 10 bbls dye water ahead of 200 sx (236 cf - 42 bbl slurry) Class G, 2% CaCl₂, 0.25#/.sx Cello-flake. Dropped plug and displaced w/17.7 bbls water. Plug down @ 0500 hrs 9/12/03. Bumped plug w/449 psi. Circ. 20 bbls good cement to surface. WOC. NU WH & BOP. PT to 250 psi for 10 minutes and 1000 psi for 10 minutes -OK. PT casing to 1000 psi for 30 mintues. Good test.
