13. Describe Proposed or Completed Operations

It is intended to revise the approved BOP stack for the subject well. Attached is the new BOP diagram and associated choke manifold diagram. This BOP and choke manifold arrangement will be utilized on a smaller, purpose fit, shallow well drilling rig. Surface to TD BOP and test pressure data will be changed to the following:

Surface to TD - 7 1/16" 3000 psi single special annular preventer. Prior to drilling out surface casing, test BOP and casing to 400 psi/30 minutes.

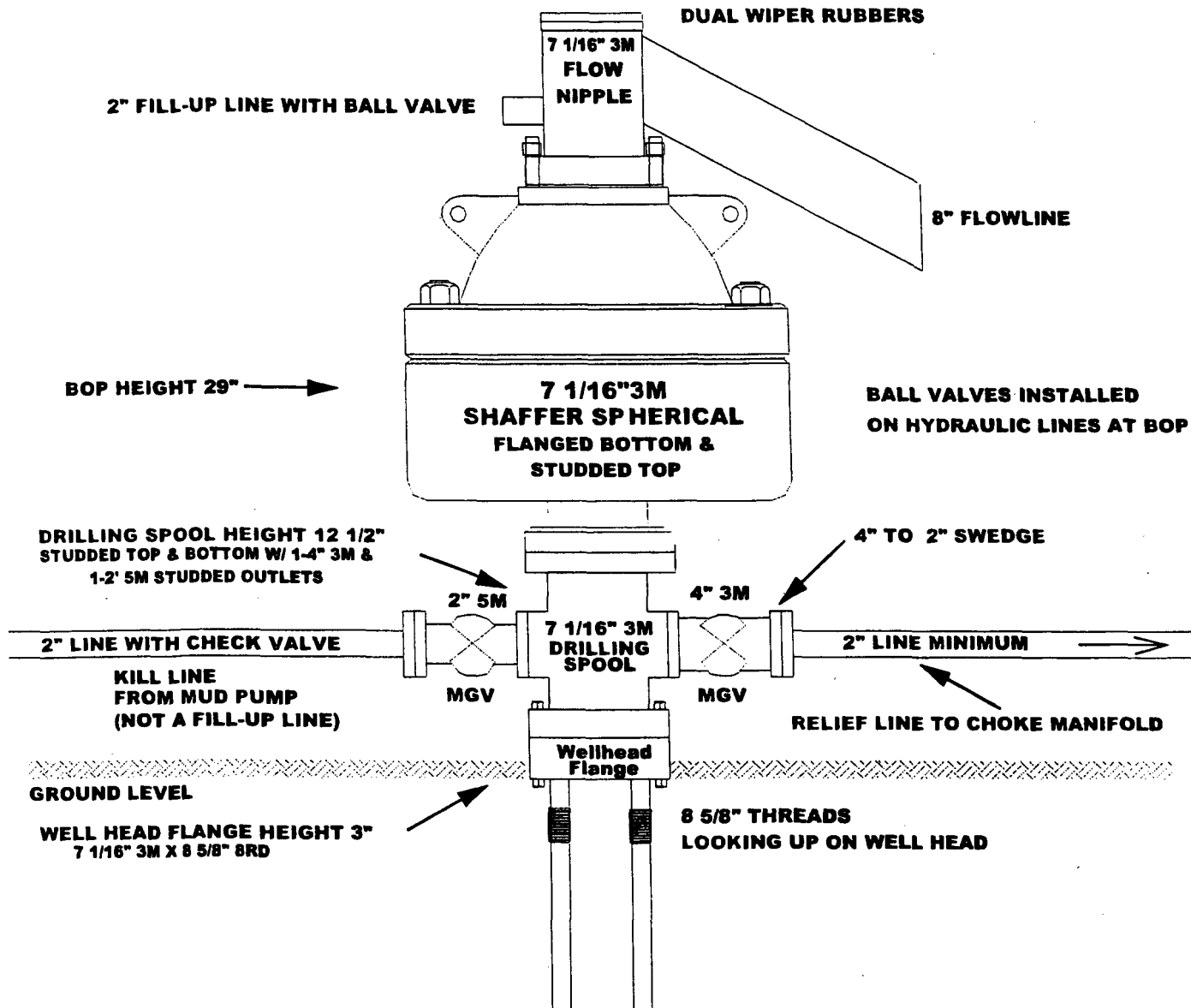

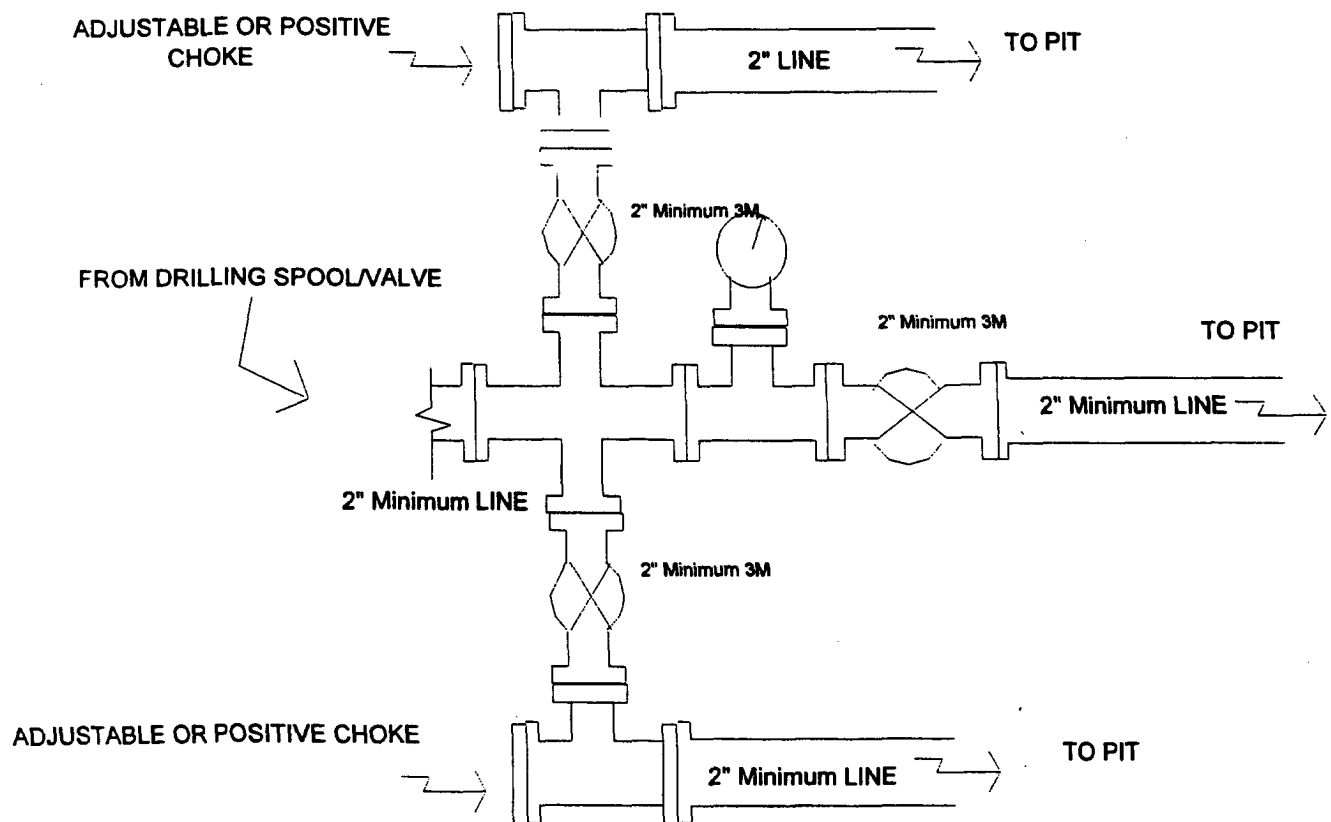
Drilling Rig
