The Navajo 36 #1 is a newly drilled Basin Fruitland Coal/West Kutz Pictured Cliffs well.

Pursuant to Order R-11363, Richardson Operating Company seeks approval to downhole commingle the "Pre-approved pools and areas": Basin-Fruitland Coal (71629) and West Kutz Pictured Cliffs (79680) in this well.

The Basin Fruitland Coal is perforated at 1335' - 1338' - 1391' - 1430' - 1439' and 1449' - 1456', 53 holes.

The West Kutz Pictured Cliffs is perforated at 1456' - 1460', 12 holes.

Due to the intermingled nature of the pools and since neither pool has enough data to prepare a reliable production forecast or predict the ultimate reserves, therefore, based on production from the surrounding sections, Richardson will allocate production as follows:

Pictured Cliffs Production = 0.50 x Total Production.

Fruitland Coal Production = 0.50 x Total Production.

The downhole commingling will not reduce the value of the total remaining production of this well.

Ownership between the two pools is identical.
