Pump 34 sx (55cf - 9.7 bbl cmt) Type I-II cmt w/20% flyash. Drop plug and went to displace when cement locked up and plug would not go. Checked plug to see if hung up in landing joint -plug ok. Tagged cmt on backside @ 30'. Pumped 12 sx (19 cf - 3.4 bbl) Premium Lite Portland cement down backside thru 1" pipe. Cmt to surface. RDMO 06/25/07. Will report PT on next sundry.


