Cement with 700 sks 65/35 Type V poz, 6% gel, 2% CaCl2, 10#/sk gilsonite, 1/4#/sk floeale tailed by 150 sks Type V, 1% CaCl2, 1/8#/sk floeale, 5#/sk gilsonite (1558 cu.ft.). Plug down @ 3:45 am on 06/28/07. Circulate 40 bbls. cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 1200 psi - ok.
