Circ 35 bbls cement to surf. Cemented 2nd stage w/700 sx Prem Lite cement w/8% Bentonite, 0.5% CD-32, 0.9% FL-52A, 2 pps Phenoseal & 0.2% Na Metasilicate (12.1 ppg & 2.1 cuft/sx) f/b 102 sx Prem Lite neat cement (13 ppg & 1.77 cuft/sx). Circ 87 bbls cement to surf.
