Due to ROW issues on the pipeline, XTO has not produced this well yet. Therefore, XTO Energy requests a 90 day extension to our request for exception to Rule 19.15.3.107 (J2) requiring all wells equipped with casing larger in size than 3-1/2" OD be tubed. XTO requests the Johnson Gas Com D #1F be produced with no tubing due to the problems with blowing down this well because of the proximity of housing. By producing this well without tubing, we will incur no waste. XTO Energy anticipates producing without tubing for approximately 90 days.
