

Circ 34 bbls cement to surf. Cemented 2nd stage w/380 sx Type III cement w/8% Bentonite, 1/4 pps Celloflakes & 2% Phenoseal (11.9 ppg & 2.6 cuft/sx) f/b 100 sx Type III neat cement (14.5 ppg & 1.39 cuft/sx). Circ 1 bbls cement to surf. Cement job completed on 5/27/07.
