Circ 20 bbls cement to surf. Cemented 2nd stage w/475 sx Type III cement w/6% Bentonite, 5 pps Gilsonite & 1/8 pps Poly-E-Flake (11.8 ppg & 2.31 cuft/sx) f/b 100 sx Type III neat cement (14.5 ppg & 1.38 cuft/sx). Circ 50 bbls cement to surf. Completed cement job on 5/27/07.


