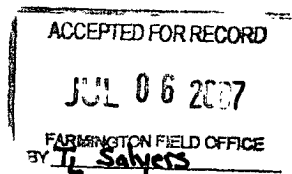

Lost circ 146 bbls into displacement - circ 10 bbls cement to surf. Cemented 2nd stage w/525 sx 65/35 Poz w/6% Gel, 5 pps Gilsonite & 1/8 pps Poly-E-flake (12.5 ppg & 1.9 cuft/sx) f/b 100 sx Type III neat cement (14.5 ppg & 1.38 cuft/sx). Good circ - 15 bbls cement to surf.
