Western Minerals requests a time extension on this well's approved APD for one year to 9/14/08. New well drilling economics indicates that this well would not be economical in the Mesaverde alone, but will need the Pictured Cliffs and Chacra open to production also. Currently, we can not open the additional zones due to State spacing rules. However, we believe that the State will allow the Chacra and Pictured Cliffs well density to go from 160 acres to 80 acres in the near future, which should make this well much more favorable economically.
