ConocoPhillips proposes to Frac Mesaverde and then remediate cement as follows:

Set CIBP @ 4100'.

Perforate 2 holes @ 3750'

Pump 125 sx Type III Neat cement to circulate cement at least 100' into 7" casing.

(Cement calculated based on 100% excess in open hole plus 50' excess into 7" csg)
