6/21/07: MIRUSU. TOH w/2-3/8" tbg. TOH w/2-7/8" liner. Ran 2-7/8" work string to 6700' & pumped 5000 gal enzyme mud clean-up treatment. Re-ran liner as before. Landed 2 7/8" 7.9# & 8.7# P-110 and N-80 liner @ 6756' MD with ON/OFF tool @ 3668'. The 2 7/8" 7.9 & 8.7# liner has 6 perfed joints w/28-0.75" holes. The bottom perfed joint is at the (MD6725-6756') with a bull plug on bottom. There are 5 more joints that are perfed spaced as follows: MD6252-6282', 5745-5776', 5248-5280', 4740-4772' and 4237-4267'. The workover rig was released 6/29/07. and PC production was resumed.
