It is intended to remove the packer and commingle the subject well in the Basin Dakota (Pool Code 71599) and Blanco Mesaverde (Pool Code 72319). The production will be commingled according to Oil Conservation Division Order Number 11363. Since this well has production history to use for allocation, the percentage will be 42% Mesaverde and 58% Dakota for gas and 100% for MV on condensate. Commingling will not reduce the value of production. The Bureau of Land Management Office has been notified in writing of this application.

Notification of the intent to commingle the subject well was sent to all interest owners via certified mail on June 4, 2007. No objections were received.
