13. Describe Proposed or Completed Operations

Burlington Resources is requesting the following change on the well design:

We would like to drill the surface hole with a 13-1/2" bit instead of a 12-1/4" bit as was approved in the original APD. There is a swelling shale near the surface of the location and drilling a larger diameter hole will allow us to more easily run the surface casing and we can avoid getting the surface casing stuck when we run it. We will adjust cement volumes accordingly to accommodate the larger diameter hole. ✓
