Pumped 399sks of 50/50/G/POZ cement. Circulated 32 BBLS excess to surface, tailed in with 517 sks of 65/35/G/POZ cement. Circulated 38 BBLS, good cement to surface. Pressure tested well to 610 PSI for 30 minutes, tested good. Job was witnessed by Marco with the BLM.
