Circ 50 hbbs cement to surface. Cemented 2nd stage w/975 sx Prem Lite cement w/8% Bentonite, 0.5% CD-32, 0.9% FL-52A, 2 pps Phenoseal & 0.2% Na Metasilicate (12.1 ppg & 2.1 cuft/sx) f/b 100 sx Prem Lite cement w/0.2% CD-32, 0.9 pps FL-52A & 2 pps Phenoseal (13 ppg & 1.77 cuft/sx). Circ 90 hbbs cement to surface. Cement job completed on 7/19/07.
