Set 9-5/8", 36#, J-55 casing @ 866' on 7/6/07 & cemented w/200 sx Prem Lite cement w/1% CaCl2, 0.2% CD-32, 0.9% FL-52 & 2 pps Phenoseal (12.5 ppg & 1.99 cuft/sx) f/b 150 sx Type III neat cement (14.5 ppg & 1.39 cuft/sx). Circ 40 bbls cement to surf. Completed cement job on 7/6/07. Pressure tested casing to 1000# for 30 min. Tested OK.
