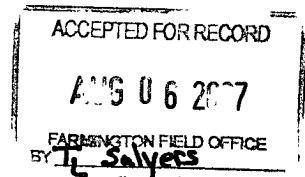

Cemented lead w/625 sx (161 bbls) 50/50 POZ cement w/2% Gel, .2% Versaset, .1% FDPC766 and tail w/75 sx (19 bbls) same slurry non-foamed. Circulated 75 bbls of cement to surface. Tested casing to 1,500 psi.
