Spud @ 5:00 pm on 09/19/03. Drill 12-1/4" hole to 247'. Ran 5 jts. 9-5/8" 32.3# H-40 ST&C casing, set @ 238'. RU Halliburton. Cement with 150 sks Class B, 2% CaCl₂, 1/4#/sk flocele (177 cu.ft.). Plug down @ 12:15 am on 09/20/03. No cement circulated. Tag cement @ 3' below surface with 1" tubing. Cement with 40 sks Class B, 2% CaCl₂, 1/4#/sk flocele. Circulate cement to surface. WOC. NU BOP. Test casing & BOP to 600 psi-ok.
