Cemented 1st stage w/315 sx 65/35 Pozmix w/6% Bentonite, 1/8 pps Polyflake & 5 pps Gilsonite (12.4 ppg & 1.9 cuft/sx) f/b 175 sx 50/50 Pozmix w/3% Bentonite, 0.1% CFR-3, 5 pps Gilsonite & 0.3% Halad-9 (13.5 ppg & 1.32 cuft/sx). Circ 11 bbls cmt to surf. Cemented 2nd stage w/451 sx 65/35 Pozmix w/6% Bentonite, 1/8 pps Polyflake & 5 pps Gilsonite (11.8 ppg & 2.31 cuft/sx) f/b 100 sx Type III neat cement (14.5 ppg & 1.38 cuft/sx). Circ 40 bbls cement to surf. Finished cement job on 6/6/07.

Production casing will be tested upon completion.
