13. Describe Proposed or Completed Operations

PNM proposes to P&A the referenced well as follows:

MOL. RU. TOH with tubing. Round trip 5.5" gauge ring or casing scraper to 2246'.

Plug #1 (Aqua Zarco perforations and top, 2246' - 2146'): TIH and set CR at 2246'. Pressure test tubing. Pressure test casing to 800#. Spot total 16 sxs Type III cement inside casing above CR to isolate the Aqua Zarco perforations and top. PUH to 514'.

Plug #2 (8.625" casing shoe and Chinle, Entrada tops, 514' - Surface): Spot approximately 55 sxs cement from 514' to surface, circulate good cement out casing valve. TOH and LD tubing. Shut in well and WOC. ND BOP and cut off wellhead. Install P&A marker. RD, MOL and cut off anchors.
