13. Describe Proposed or Completed Operations

PNM proposes to P&A the referenced well as follows:

RCVD AUG 21 '07

OIL CONS. DIV.

MOL. RU. TOH with tubing. Round trip 5.5" gauge ring or casing scraper to 2353'.

Plug #1 (Aqua Zarca perforations and Poleo top, 2353' - 2253'): TIH and set CR at 2353'. Pressure test tubing. Pressure test casing to 800#. Spot total 16 sxs Type III cement inside casing above CR to isolate the Aqua Zarca perforations and the Poleo top. PUH to 607'.

Plug #2 (8.625" casing shoe and Entrada top, 607' - Surface): Spot approximately 65 sxs cement from 607' to surface, circulate good cement out casing valve. TOH and LD tubing. Shut in well and WOC.

ND BOP and cut off wellhead. Install P&A marker. RD, MOL and cut off anchors.
