Set 5-1/2", 15.5#, J-55, LT&C casing @ 6868' on 7/26/07 & cement 1st stage w/255 sx of Class G (HLC) cement w/6% Bentonite, 5 pps Gilsonite & 1/8 pps Poly-E-Flake (12.4 ppg & 1.9 cuft/sx) f/b 175 sx 50/50 Poz w/2% Bentonite, 0.1% CFR-3, 5 pps Gilsonite & 0.3% Halad-9 (13.5 ppg & 1.32 cuft/sx). Circ 12 bbls cement to surface. Cemented 2nd stage w/465 sx Class G (HLC) cement w/6% Bentonite, 5 pps Gilsonite & 1/8 pps Poly-E-Flake (12.4 ppg & 1.9 cuft/sx) f/b 100 sx Type III neat cement (14.5 ppg & 1.38 cuft/sx). Circ 40 bbls cement to surf.

Production casing will be tested upon completion.
