In the above well was set 7 jts of 9 5/8", ST&C, 32.3# casing at 265', the casing joints were 20' rather than the 40' joints usually used. The shallower depth of the casing set was also due to damaged threads on the casing used in this well. The depth of 265' was approved by Jim Lovato with the BLM.
