08/20/07 spud 8-3/4" surface hole. Drilled to 136'KB. Ran 3 jts (120.65') of 7", 20#, J-55, ST&C new casing and set casing at 126'KB. Cemented with 65 sx (77 cu. ft.) of Type 5, 3% CaCl<sub>2</sub> and 1/4 #/sk celloflake. Circulated 5.0 bbls of good cement to surface.

08/21/07 Nipped up the BOP. Pressure tested the BOP,choke manifold and casing to 250 psi - low and 1000 psi - high.

08/23/07 TD 6-1/4" hole at 1913'. Ran 46 jts (1882.76') of 4.-1/2", 10.5#, J-55, ST&C production casing and set casing at 1888' KB. Insert float is at 1873' KB and the top of marker joint is at 1435' KB. Cemented with 150 sx (309cu.ft.) of Type 5, 2% sodium metasilicate, 1/4#/sk celloflake, followed by 75 sx (90 cu. ft.) of Type 5, with 1/4# celloflake. Bumped plug to 1500 psi. Circulated out 7 bbls of good cement.
