08/01/07 - Acidize Mesaverde perfs from 5934' - 6124' with 1500 gals 15% HCL.

08/02/07 Unseat packer. TIH and retrieve RBP. TOH and lay down packer and RBP. TIH with 2.375" tubing to 5900'.

08/03/07 TIH, tag fill @ 8120'. clean out with air mist to PBTD of 8188'.

08/06/07 Land 2.375" tubing @ 8076'. ND BOP. NU WH. Return well to production.
