09/02/07 Drill 8.75" hole to 4201'. Run 100 jts. 7" 23# J-55 LT&C casing, set @ 4201'. RU Halliburton. Cement first stage with 150 sks Class G, 5#/sk gilsonite, 1/2#/sk flocele (183 cu.ft.). Plug down @ 1:30 am on 09/02/07. Circulate 18 bbls cement to surface. Circulate between stages. Cement second stage with 575 sks Halliburton premium light, 10#/sk gilsonite, 1/4#/sk flocele, 2% CaCl2 tailed by 50 sks Class G, 1% CaCl2 (1187 cu.ft.). Plug down @ 8:15 am on 09/02/07. Circulate 115 bbls cement to surface. WOC. RD Halliburton. ND BOP. Release rig @ 6:00 am on 09/03/07. Will test casing & BOP before drilling out cement.
