On 9/9/07 the above well was perforated in the Pictured Cliffs zone from 3,479' to 3,568' with 4 SPF, 0.34" EHD, 120 degree phasing, for a total of 21 holes. On the same date the well was fracture treated with 107,733 gal Delta 140 with 203,230# 20/40 BASF coated sand with SWNT. The average rate was 22.4 bpm, average pressure 1631 psi, and the final frac gradient was 0.78 psi/ft. ✓
