On 9/6/07 the above well was perforated in the Dakota zone from 8,304' to 8,406' with 4 SPF, 0.34" EHD, 120 degree phasing, for a total of 21 holes. On 9/8/07 the well was fracture treated with 69,564 gal Delta 200 with 50,064# 20/40 Ottawa sand. The average rate was 18.4 bpm, average pressure 5088 psi, and the final frac gradient was 0.76 psi/ft.
